

As a recipient of the Richard Dickens Music Scholarship, Ellie is currently pursuing a degree in music at the University of British Columbia. So, while visiting her hometown of Kamloops in the summer, she produced a solo concert event with proceeds going into the scholarship fund for the benefit of future musicians. The evening filled Summit Drive Church with music lovers of all ages, eager to support education in the arts. HELPING FAMILIES MAKE LIFE EASIER



Organizations working together helped to make dollars go further. Funds from a spring grant along with the ALS Walk and ALS Golf Tournament, Rick and Laurie Dunbar of Kamloops were able to take advantage of the Equipment Loan Program (ELP). This program dedicates itself to the families living with ALS by supplying the much needed equipment required to allow these families to live a somewhat more "normal" life. Much needed equipment may come in the form of wheelchairs, slings, breathing apparatus' and many more.

As Rick's disease progressed, Rick and Laurie were aware that Laurie would not be able to continue to move him around, toilet and shower him. They learned that the equipment and supplies needed to care for Rick would be loaned to them. Without the sophisticated wheelchair, hospital bed, sling and trilogy ventilator, life would have been much more difficult for Laurie to manage Rick's daily care.

Journeys to visit Rick's father and to attend medical appointments in Vancouver would

not have been possible without the help from ELP. Their hotel rooms were equipped with everything they needed to make their stays as comfortable and stress free as possible.

Sadly, one of the last trips they would make as a family together with their daughter Tusha, would be to the ALS Volunteer Recognition Awards Banquet in Richmond on April 5, 2016. Rick was the much deserved recipient of the Exemplary Public Awareness Award. Rick passed away on April 16, 2016 and will be missed by many in the community.

GORDON GORE STORY



The BIG Little Science Centre (BLSC) started in February 2000 by Gordon R. Gore, a retired science teacher who is dedicated to teaching science in an interactive environment. One step through the doors and both young and old are delighted with the magic of science and the opportunity to learn in a hands on environment. Spend a few moments with Gordon and you can easily see his passion for science and why his contributions to our community are often recognized.



The Gordon R. Gore Scholarship Fund was initiated by the Big Little Science Centre in Gordon Gore's name and is awarded to students in the field of science. A legacy of science and a teacher well known for how he taught his students will be there for generations to come through this scholarship.

Gordon's approach to science and learning made a positive impact on countless students: "One of your many strengths was that you treated all your students as important, not just the bright ones. They might not all have become physicists, but they came away with self-confidence and an interest in learning."



Gordon's accomplishments and positive impact were felt not only in the schools where he taught but in the community as well. He has been recognized for many distinctions including TRU Doctor of Letters, BC Innovation Council, BC Provincial Service Award and the 2015 Diamond Jubilee Canadian Award. Most recently Gordon was awarded the Meritorious Service Cross by The Honourable Judith Guichon, OBC Lieutenant Governor of British Columbia.

Nowadays Gordon can be found behind the camera engaging his photography

skills. Even in this his legacy of community support continues. He has several small photo albums that he generously donates to a variety of organizations for their fundraisers.

LEAVING A LASTING LEGACY IN LOVING MEMORY OF JANN LM BAILEY Written by Margaret Chrumka

n 2008, Jann LM Bailey had been Executive Director with the Kamloops Art Gallery for 21 years and her world was about to change. Along with a number of community members, she worked for the creation of a purpose-built, regional art gallery in Kamloops and realized this dream in 1998. The Kamloops Art Gallery had moved from what is now the children's museum in the Kamloops Archives & Museum building into a 29,000 square foot space with three exhibition areas, an art library, storage for the growing permanent collection and studio space for art camps and

workshops. This achievement was a highlight of Jann's career.

In 2005, Jann worked with curator Scott Watson of the Helen and Morris Belkin Art Gallery at the University of British Columbia in bringing artist Rebecca Belmore as Canada's representative to the Venice Biennale. This was an incredible achievement for these galleries given their size and capacity to raise funds, this was also a stellar achievement for Jann. Since that time the responsibility to



raise the necessary resources and provide the artist with the technical expertise to mount an exhibition at the Biennale now only falls to the National Gallery of Canada in Ottawa.

In 2008, Jann was diagnosed with leukemia and she was encouraged by her doctors to "get her affairs in order." Her efforts on behalf of the Gallery had to take a back seat to her health. A committed

community advocate, Jann did not even question that a portion of her estate would go to the then Kamloops Foundation. She also set up a fund in her name with an initial donation of \$25,000. The Jann LM Bailey Foundation Fund was created to provide future Kamloops Art Gallery executive directors with the means to purchase art work of importance to the Gallery. The economic changes of 2008 to 2010 and dwindling art acquisition budgets across the country, compelled Jann to ensure the Kamloops Art Gallery was able to acquire work of regional significance always.


The fighter that she was, Jann survived cancer and returned to work at the Gallery in 2010. In 2013, interest from Jann's fund was combined with support from the Canada Council for the Arts and other private donors to add Dana Claxton's work Baby Boyz Gotta Indian Pony to the Gallery's permanent collection. Prior to and since then accrued interest has been re-invested in the fund.

Jann's sudden passing in the fall of 2015 was unexpected and much too soon. Established with foresight in 2008, the Jann LM Bailey Foundation Fund represents Jann's enduring commitment to the value of visual art in our lives and to the importance of supporting artists by the acquisition of their work into public collections. With the interest from this

fund, her legacy will live on as the Gallery's permanent collection of art work continues to grow and represent this region's artistic achievements.
